

Education was a large part of the American Dental Assistants Association's Annual Session in Las Vegas, October 10-14, 2011. The ADAA in conjunction with the ADA provided courses to more than 2,000 dental team members over the course of the meeting.

A large portion of the focus was how we might better serve the student members. The result was adoption of student chapters at dental assisting programs of 800 hours or more throughout the US. Pilot programs are already operating at Citrus College in Glendora, California and Mount Diablo Adult Education in Concord, California. A student trustee position was created on the ADAA Board of Trustees to provide representation for all ADAA student members. Jennifer Broyles, a student at Citrus College in California, was appointed to fill the position.

LAP funds of \$3,000. was awarded to the state of California to continue in their endeavor to help dental assistants in their state.

The House of Delegates voted for an increase in dues. \$5.00 student increase and \$10. for active members. The top 10 benefits of a \$10. dues increase are:

- 1. Free, unlimited CE to all its full dues paying members. Starting January 1, 2012, those members who opt for paying for a full year's dues when billed will be granted the right to unlimited education for the duration of their membership. Those opting for half-year payment or less through debit payments will receive six hours of education until their membership is fully funded.
- **2. Enhanced use of social media.** Twitter, Tweeting and Facebook. Networking is a regular part of life for the

young professionals and ADAA must keep up with these developments. Students are our future.

- **3. Conversion of E-members.** More revenue could mean more aggressive outreach with more incentives to make E-members Active Members. Currently there are 15,000 e-members.
- **4. Recruitment and retention of active members.** Active members are always the first in line to benefit from ADAA improvements.
- **5. Improved ADAA website.** News of the profession, links to everything helpful, all in one spot and guidance on where to go for more information. The website is meant to be entertaining, enlightening, educational and helpful to our members. The dues will help to fund its expansion and improvement.


nominated and supported by all three employee groups (management, faculty and classified). The award was

# **Salem Free Dental Clinic**

In the Spring of 2005, the West Salem Foursquare Church began seeing medical patients in an auditorium at Walker Middle School. volunteers working at the clinic noticed the dire need many of these people had for dental care.

Some leaders at West Salem Foursquare Church and Salem Alliance Church created a small committee to determine what was needed to start a dental clinic. After approximately 4 years of planning, the completion of a new building known as Broadway Commons, and generous

donations from local businesses, dentists and community members, the city of Salem now has a free dental clinic with two treatment rooms to support many adults who would otherwise not be able to receive care. Patients are referred to the dental clinic through the medical clinic and, currently, the only service is dental extractions. The clinic is open two mornings per month, usually a Friday and Saturday. In about 4 hours per day, the volunteer dentist, assistants and hygienists see an average of 8-9 patients. The clinic has currently



# Georgia School Testing Green Tea Lozenge as Dry Mouth Remedy

Researchers at Georgia Health Sciences University are conducting a clinical trial using an all-natural green tea lozenge to treat dry mouth, or xerostomia, a condition that affects 40 percent of American adults. According to an article in the Spring/Summer issue of Word of Mouth, the journal of the university's school of dentistry, Drs. Stephen Hsu, Douglas Dickinson, Stephen Looney and Kalu Ogbureke are hoping that their research will show that the lozenge can provide relief without the side effects of prescription medication.

"With green tea polyphenols, we have an agent that's helping to correct the salivary gland's abnormal behavior," the article quotes Dr. Douglas Dickinson as saying.

For their research, Drs. Dickinson, Hsu, Looney and Ogbureke have received one of three International Innovation in Oral Care Awards sponsored by the International Association of Dental Research and GlazoSmithKline. The award amounts to \$75,000.

According to the article, a green tea lozenge could be available to the public by the end of this year.

n Wednesday, Dr. Oz had a show on the fastest growing cancer in women, thyroid cancer. It was a very interesting program and he mentioned that the increase could possibly be related to the use of dental x-rays and mammograms. He demonstrated that on the apron the dentist puts on you for your dental x-rays there is a little flap that can be lifted up and wrapped around your neck. Many dentists don't bother to use it. Also, there is something called a "thyroid guard" for use during mammograms. By coincidence, I had my yearly mammogram yesterday. I felt a little silly, but I asked about the

guard and sure enough, the technician had one in a drawer. I asked why it wasn't routinely used. Answer: "I don't know. You have to ask for it." Well, if I hadn't seen the show, how would I have known to ask?

### **Dental Bib Chains Pose Cross Contamination Threat**

Charlotte, NC – June, 14, 2011 / PRNewswire/ — Wet, used towels left in the gym. Dirty tissues discarded by someone suffering from a nasty cold. You wouldn't think of touching these items. But unknowingly, you may be sharing something that could be just as filthy and potentially dangerous when you visit a dental office. Infection control specialists call this cross contamination.

When an unsterilized bib chain is placed around your neck, you may be exposed to dangerous pathogens including pseudomonas, E. coli and Staph aureus – the most common cause of staph infections and a potential "superbug."

Noel Kelsch, a national infection control columnist, Registered Dental Hygienist and former President of the California Dental Hygienists' Association, conducted a study on various types of dental chains and clips after seeing debris falling from a chain she had planned to use to protect her uniform at lunch. What she found led her to write an article titled "Don't Clip that Crud on Me" for RDH Magazine, a trade publication for dental hygienists.

Cross contamination can occur when a bib chain 'grabs' onto hair or accumulates patients' sweat, make-up, and neck acne, not to mention the oral substances that spray out of the mouth. During a dental cleaning, saliva, plaque and even blood can come in contact with the bib and bib chain. While you might think these types of nasty contaminants won't find their way into your system, all it takes is for you or one of the dental workers to come in contact with them. If you touch your neck after a dental visit and then rub your eye, you may have just cross-contaminated yourself.

"Studies have shown the more cracks, crevices and indentations on a bib chain, the higher the bacterial count. The problem with this when we use the same bib chain with patient, after patient, after patient, the accumulation creates a risk for cross-contamination."

One specific study Kelsch conducted involved taking samples of bacteria found in a major U.S. airport bathroom and comparing them to the bacteria found on a used bib clip.

"What we were trying to do was put across to the public how bacteria-laden a bib clip can be, and what we discovered was, by looking at a bathroom floor at a busy airport, and looking at this bib chain, we got about the same level of bacteria in both of them. This is a risk that everyone needs to be aware of."

As expected, disposable clips and holders opened fresh for each patient, were free from contaminants and posed no cross-contamination threats. "As an advocate for patient safety within the dental profession, one of the most important things I can do is keep patients out of harm's way. By simply educating the public about

this possible crosscontamination, we can make an impact and keep our patients out of harm's way."

Herfindings echoed a study conducted by the University of North Carolina at Chapel Hill's School of Dentistry Oral Microbiology Lab that found bib chains and clips are potential sources of

contamination. In sampling 50 bib clips from various hygiene and dental operations, researchers discovered one in five bib clips were contaminated with "significant microorganisms," according to an article in Dental Health Magazine.

"Society is really putting an emphasis on healthier living. If you go out into society now, you can see it everywhere you go. When you go to the grocery store, you'll see that they have wipes for disinfecting the cart; when you go into a gym, they'll supply you with items for helping you keep the equipment safe and free of bacteria. By simply going into your dentist's office and insisting that they use a disposable bib holder, instead of a bib clip, you're eliminating that harm factor."

In addition to providing patients with a safer dental visit, Kelsch says that disposable dental bib holders are critical tools in the fight against the creation of more "superbugs."

"If the infection route is destroyed – specifically, this bib chain is eliminated – we're not going to have the chance of cross-contamination and no disease is going to occur."
